New Change from Department of Education

The federal government has implemented Year Round Pell which means you may choose to use part of your Pell award during the Summer session. One of the major requirements to use the Pell Award is the student must be enrolled in at least half time hours by the census date of the Summer Session which he/she enrolls. (No exceptions.) An undergraduate must be enrolled in a minimum of two (2) hours for Sessions 1 and 2 and a minimum of four (4) hours for Session 3 to be considered for Summer Pell. In addition, you must meet all requirements to receive federal funding including being Pell Grant eligible. Should you use your Pell during the Summer Session, it will count against your Pell Lifetime Eligibility Used Limit (600%). IMPORTANT: It is the student's responsibility to read all information below as well as ALL correspondences sent to you regarding financial aid.

A. Processing

- Your application will be reviewed to determine eligibility beginning **April 3, 2018**. A notification will be sent to your Xavier e-mail account. If you are eligible for Financial Aid, you can review your award on Banner Web and you *must* take action immediately to accept and/or decline your award. Failure to accept or decline your award within a reasonable time may result in cancellation or loss of eligibility of your aid.
- Financial Aid is based on your eligibility and the availability of funds.
- Your award will be based on the most current NSLDS records at the Department of Education. Should your account be updated by the Department, your account will be reviewed.
- If you are a first-time student loan borrower for the summer semester, you must complete both the Entrance Counseling and Master Promissory Note (MPN) at www.studentloans.gov. Otherwise, your aid will not disburse to your account.
- Submission of the form does not guarantee awarding.
- If your Parent is applying for a Parent Plus Loan at www.studentloans.gov, or if you/parents are applying for a private loan, please do so early and notify our office via email as soon as possible.

B. Please keep in mind that you are not eligible to receive Summer aid, if the following conditions apply to you:

- You have already received the maximum aid in Direct Loan (Subsidized and/or Unsubsidized), Graduate PLUS and/or SEOG allowed based on your grade level or reaching your annual and/or aggregate limits during the 2017-2018 academic year.
- You are not meeting Satisfactory Academic Progress (SAP) in accordance with the SAP Policy. Click below to view: <http://www.xula.edu/financial-aid/Satisfactory%20Academic%20Progress/sap-policy.html>. If you are awarded for Summer, your award will be **CANCELLED**.
- You are classified as a "Transient" (Guest/Special Student) – Non Degree Student.
- You have not been admitted as a certificate or degree-seeking student; but a non-degree seeking student.
- If you are enrolling in and your attendance reflects less than half-time hours (for Federal Loans, some Scholarships and some Grants).

C. Submission of Form

- To ensure timely processing of your form, please submit your form by using one of these methods:
